

# **Global Food Systems Summit Dialogue**

The UN Secretary-General will convene the Food Systems Summit in 2021 to launch bold new actions towards SDG 12, responsible consumption and production. The speakers from diverse field of expertise will focus on five action tracks

Ensure access to safe and nutritious food for all

equitable livelihoods in food systems.

Shift to sustainable consumption patterns Boost nature-positive production

Advance equitable livelihoods

Build resilience to vulnerabilities, shocks and stress

EEG participated in December in the virtual dialogues that were organised to build discussions and set the tone for the Summit.

1) EEG Chairperson attended on 1st December joined the 1st dialogue of the series hosted by the Special Envoy of the UN Secretary-General and the Co-Leads of the One Planet Network's Sustainable Food Systems Programme.

It aimed at gathering the experiences and inputs of ground level initiatives contributing towards sustainable consumption and production. Some of the key areas of discussions included:

- Farmers and food producers lead the way to sustainable and equitable food systems by participating in the formulation of policies that impact them.
- 2) Organised by UN Department of Economic and Social Affairs, on 16th December EEG Chairperson attended the virtual session on advancing

In 2021, the global efforts need to be aimed at securing nutrition for everyone, generating equitable livelihoods and mitigating climate change. The expert speakers from the field of food systems, population trends and rural development addressed the key areas on:

- Small and medium enterprises are drivers of sustainable local food systems, creating employment and providing healthy & nutritious foods to local consumers.
- Agriculture and land use strategies drive the promotion of agrobiodiversity and stimulate local food productions in a way that provides sustainable livelihoods and healthy diets for all.
- Innovative governance and incentives at all levels foster cross-sectoral collaboration across policy areas (like biodiversity, climate change, health, trade, etc.)
- Responsible and accessible investments on sustainable and equitable food systems by financial institutions and private investors are the norm.
- Impact of COVID-19 on livelihoods especially the developing countries
- Systemic implications of population movement—and disruptions to this movement—on food system livelihoods
- Examples of agricultural and non-agricultural technologies or tools that can be utilised in rural settings to ensure sustainable productivity

# Food Systems MSGM Mechanisms

December A side event on Food Systems multi-stakeholder governance mechanisms (MSGM) in-line with the 3<sup>rd</sup> Global Conference of the Sustainable Food Systems Programme was held virtually on 2nd December.

It was co-organised by UNEP, WWF, Hivos-RUAF, Rikolto, Bioverse Alliance and International Center for Tropical Agriculture (CIAT), with the support from the German Government. EEG joined this interesting discussion, wherein the results and experiences of 3 multi-stakeholder

governance mechanisms (MSGM) were brought into light.

In the opening session, UNEP representative for food systems talked about establishing a holistic approach and inclusiveness of multistakeholders as a way forward to deal with serious global challenges and build governance structures for sustainable food systems. Whereas,

the One Planet Network SFS Programme consultant emphasised on awareness and knowledge sharing on multi-stakeholder mechanisms (MSMs) as important to create innovations on sustainable strategies.

Several case studies were shared from different countries. The speakers discussed the role that their initiatives played in helping cities and countries to promote sustainable food systems approaches, especially under the COVID-19 situation.

These case studies will also be a part of Education Learning Tool on MSGM that will strengthen the common vision for inclusive collaborations.

The event also raised the political importance of sustainable food systems among public and private sector leaders.

# Regional Consultation West Asia

December

EEG Chairperson on 8th December participated virtually in the West Asia Regional Major Groups and Stakeholders Consultation meeting. It was themed on 'Strengthening

actions for nature to achieve the SDGs' and facilitated discussions regarding the UNEA-5, scheduled for February 2021.

With the main focus on the mid-term strategy and programme of work, the Regional Director and Representative of UNEP West Asia and Programme Manager at UNEP Governance Affairs (Civil Society Unit) led the course of the consultation. These regional consultations are being hosted by UNEP since 2002 to identify and advance the priorities towards environment and sustainable development. EEG has been actively engaged in these consultations.

The triple planetary crisis caused by humans and as explained in the meeting includes climate change, biodiversity loss and pollution due to unsustainable production and consumption patterns. The group discussed the need for three key thematic programmes - Act for Climate, Act for Nature and Act for Chemical Pollution, which will strengthen science and policy for environmental governance, finance and economic transformation, and digital transformation. Collective action and transformational strategies are required to achieve impactful results towards green. The consultation meeting was concluded on the reminder note that 'the world cannot go back to business as usual after COVID-19'.

# EEG Attends Informal Consultation on UNEA-5

EEG attended on 8th December, the open-ended informal consultation to discuss the formulation of the draft statement of the virtual December session of UNEA-5 in February 2021. Due to the pandemic, it was decided (in October 2020) that there would be a short, virtual Assembly in February 2021 and a longer, more substantial in-person Assembly in February 2022. However, it was found in the last few months that there were differing views among Member States and stakeholders regarding the best course of action for a concluding message from the virtual session of UNEA-5 (February 2021). This meeting was convened by the President of UNEA-5 who proposed the following:

- Defer consultations on the zero draft ministerial declaration on the overarching theme of UNEA-5: Strengthening actions for nature to achieve the Sustainable Development Goals for the time being; and
- Identify other broad political messages specifically for the first part of UNEA-5 (February 2020)

In the meeting, the Member States were provided with a platform to provide their feedback and guidance on this proposal. Despite the pandemic creating considerable challenges globally, it was reiterated that multilateral and intergovernmental work must continue. Member States was requested to be flexible and look upon the virtual session of UNEA-5 in February 2021 as an opportunity to show their continued commitment and dedication to the environmental dimension of global sustainable development. During the meeting, several Member States subscribed to the agreement that substantive work and negotiations of resolutions must be deferred until the resuming session of UNEA-5 in February 2022. Others believed that a low-profile, and merely administrative UNEA-5 in February 2021 will not be effective. In fact, they believe that abandoning the ministerial voice of the global environmental authority at a time it is most needed will be detrimental to the global environmental agenda. It was also suggested that if a consensus on this issue was not possible, the President could develop a President's Message instead of a Ministerial Declaration. One Member State highlighted three key aspects in which UNEP has an important role:

- To ensure that the post-COVID recovery is green, just and resilient and aligned with the environment and climate agenda
- 2. Improve governance in addressing marine pollution and continue efforts to advance the adoption of a new post-2020 international governance framework on chemicals and waste management
- Setting a global environmental agenda by building synergies between different environmental agreements

The President concluded the meeting by saving that we need to remind the world of the importance of Nairobi as the global environmental hub and strongly reiterated that environmental challenges cannot be ignored just because of the pandemic.

Thus, considering the concerns of Member States, the President said that the Ministerial Declaration of UNEA-5 will be deferred until the second session in February 2022. The message, thus, for February 2021 will be simple: recognise the pandemic and the environmental crisis.

### GISD Deals call 2020

December

EEG Chairperson was invited to join the final GISD deals call of 2020 which was held on 9th December on a virtual platform. The session saw Women's World Banking present their second fund targeting financial inclusion for low-income women. The underlying principle and strategy of WWB is an uplifting and financial inclusion of under privileged women. Their aim is to invest in financial institutions in emerging markets that are untapped and have a potential for substantial ROI opportunity. The group addresses SDG no 1- No Poverty; SDG no 5- Gender Equality, and SDG no 8 - Decent Work and Economic Growth.

## **GPML Webinar on Upcoming Digital Platform**

EEG attended on the 10th December, a webinar organised under the aegis of the Global Partnership on Marine Litter (GPML) titled - "Towards a GPML Digital Platform".

This webinar provided a high-level overview of the upcoming GPML Digital Platform as well as opportunities to discuss multi-stakeholder functionalities. Launched at Rio+20, the GPML is a voluntary stakeholder platform that plays a critical role in bringing together a diverse group of stakeholders to work on addressing Marine Litter and Plastic Pollution. Objectives of the GPML Digital Platform:

- Integrate data and information from multiple sources
- Connect stakeholders
- Identify gaps and priority actions 3.
- Coordinate and guide action based on the best available knowledge
- Facilitate target setting and measuring progress

From the get-go, an interesting feature about the Digital Platform that was highlighted was the integration of Sam - an IBM AI Virtual Assistant who is equipped to answer questions regarding marine litter and microplastics (this was demonstrated in great detail).

Other important tools of the Digital Platform included a Plastic flow Model, Interactive Dashboard for Stocktaking, Environmentally Sound Technologies, Policy Toolkits and Technical Inventory. Each of these will be populated with information and case studies from across the globe, providing greater opportunities for knowledge sharing and collaboration. Next, was an overview on Global Marine Litter Tracking Simulations, which answered the overarching questions - "Where does the marine plastic waste go once released into the ocean?" and "Where does the marine plastic waste found on the coast come from?" The speaker explained that the GPML utilises tracking simulations that include the following three

- Particle seeding that represents realistically the input of the mismanaged plastic wastes (MPW) into the ocean
- 2. High-resolution global ocean circulation and wind data
- State of the art Lagrangian analysis tool (Ocean Parcels)

This was demonstrated through an interactive map that showed how particles from Asia ended up in the Pacific and vice versa. Finally, attendees were also invited to join the GPML and be a part of the growing community to coordinate actions on a regular basis.

EEG would like to congratulate the GPML and look forward to contributing to and utilising the unique features of the Digital Platform in the future.



# 10<sup>th</sup>

## **UN75 Dialogues-Youth in Action**

EEG attended on 10<sup>th</sup> December the, 'UN75 Dialogues: Youth in Action'- a series of webinars aiming to address Arab youth's needs, expectations and ambitions, and hence the achievement of the SDGs. The webinar was organised by the office of United Nations in the United Arab Emirates, UNFPA Arab states and MBC AL AMAL. Today, 30 % of Arab population is between the ages 15 to 29. Regions where

the youth are empowered thrive. The online webinar meeting was facilitated by UN representative and Arab Youth Activists. Youth were encouraged to pursue their dreams and not be afraid of failures. Challenges being faced by youth today such as political instability, unemployment, health and access to resources were acknowledged. Examples of young leaders who stand as role models were put forth. Youth activists with diverse experiences in business startups and charity investments were invited to share their experiences to encourage youth to open startups and raise their voice through different platforms. Online platforms especially the Arab Youth Centre and UN Volunteering websites were highlighted as platforms through which Arab youth can benefit. 'Regional Youth Platform', a platform yet to be launched for showcasing opportunities for youth and where youth can interact with each other was also discussed. The role of youth in volunteerism was amongst the topics discussed such as the participation of one young activist in the creation of The UN Youth Charter for Arab youth. The charter is still in development stages. The Charter aims to cover all major dimensions that concern youth: Challenges youth face, rights, freedom, youth in conflict zones, youth with disabilities, employment policies, security and education in the Arab region. Towards the end, in the question and answer session, the youth were again encouraged to be proactive, search or create opportunities, raise their voice and be politically involved in decision making.

# 10<sup>th</sup>

## EEG Attends Second Geneva Dialogues

**December**EEG attended the second session of the Geneva Beat Plastic Pollution Dialogues via a virtual platform for the topic of "Plastics, Climate and Air Pollution". The session focused on climate and air pollution. Six keynote speakers from Government, Private entities and Academia gave their perspectives on the topic with examples of their legislations, activities, research. The first two speakers were the Permanent Representative of the Republic of Fiji and United Kingdom to the United Nations Office and other international organisations in Geneva. They shared the

They shared the action each country has taken to solve growing plastic problem in their respective countries. The highlights were that, UK is aiming for at least a 68% reduction in greenhouse gas emissions by the end of the decade, compared to 1990 levels. On the other hand, Fiji is working on 2050 Today initiative by the Swiss government, focusing on reducing its footprint and is also trying to grow the conversation around addressing sustainable plastics trade.

Three speakers from Center for International Environmental Law (CIEL) and two researchers at University of Strathclyde elaborated their research on the topic. The 1st speaker stated that franking of gas, oil and unburnable coal has made natural gas really cheap. Furthermore, petrochemicals are the leading driver for oil growth demand. His highlighted message to take away was that every step of plastic production has emissions and plastic pollution is a growing threat to Earth's climate. Researchers at University of Strathclyde studied the remote area and atmospheric transport of plastic over the past few years. In their study, the nano-plastic participles and its prevalence in the atmosphere, they found up to 5,700 micro plastics per m³ in mega cities and also discovered micro plastic everywhere including artic snow and ice to high above mountain air in Everest. To conclude the dialogue, the head of Climate & Clean Air Coalition (CCAC) shared their initiative on Air Pollution and mentioned that plastic pollution issues across the globe need to be studied more closely and addressed immediately. Forging partnerships are the key drivers to change. EEG is thankful for the invitation to the dialogues. The session was interesting and extremely informative. # The 19<sup>th</sup> cycle of the Annual "Clean Up UAE" Campaign

Emirates Environmental Group (EEG), the leading NGO devoted to protecting the environment through the means of education, action programmes and community involvement, concluded one of its flagship events, the 19th annual "Clean Up UAE" campaign, held under the patronage of the UAE Ministry of Climate Change and Environment (MOCCAE). Originally planned for two weeks in the last month of the year, the campaign had to be shortened due to the pandemic and was held on 12th December. This year, the campaign was organised in association with Dubai Municipality and Saih Al Salam Protected Area Management; the event saw the participation of His Excellency the Acting Undersecretary of Ministry of Climate Change and Environment. A total of 5,254 participants from different nationalities, gender and age groups joined the cleanup at the Al Marmoum Protected area - Al Qudra lakes, other locations that were opened for the cleanup were; Dubai Industrial City and Al Ruwais, Khalifa Port, the Industrial City in Abu Dhabi, covering an area of more than 23 km and collecting nearly 13 tonnes of waste across the 8 locations. The Co-Founder and Chairperson of EEG, said: "At Emirates Environmental Group, our aim is to support the UAE government with its larger goals and objectives of sustainability. Apart from this, we also work towards creating awareness for



the public and private sector towards the existing sustainability issues in the region. We would like to thank everyone for their efforts and contribution towards the 19<sup>th</sup> annual edition of this initiative. It is important that we as a society consciously come together to work towards a better tomorrow for everyone."

His Excellency the acting Undersecretary of the Ministry of Climate Change and Environment said: "Protecting the environment and sustaining its natural resources and biodiversity are strategic priorities for MOCCAE. In this context, we work to ensure a safe and sustainable future for everyone through driving effective environmental action that integrates legislation with on-the-ground programmes and initiatives. In line with the directives of the wise UAE leadership, we are keen to involve the community in environmental protection efforts, therefore we are proud to support the Clean Up UAE, and applaud the work of EEG." Shoemart came on board as the main sponsor while McDonald's UAE and Dabur International co-sponsored the event. Dubai Investments and Dubai tourism joined the campaign as support sponsors. President, International Relations of the Chamber started the discussion by sharing the important updates of the last quarter of 2020. The CEO of Dubai Department of Tourism and Commerce Marketing (DTCM) gave the insightful presentation on the activities of Dubai that ensures a progressive path moving forward. He gave a walkthrough of 3 phase campaign to explain the strategies adopted amid COVID-19. From June till December 2020, it also held Global Umbrella Influencer Programmes through relevant and credible influencer content to minimise the perception gaps and raise confidence for the potential tourists. DTCM continues to leverage its content, highlight Dubai's progress and leverage

further developments in moving beyond the pandemic. The Chief Economist for Asia Pacific, Middle East and Africa MasterCard's Economic Institute shared the global and UAE's macro-economic development in the recent month. # EEG Attends Webinar on Key Findings of Emissions Gap Report 2020

On the 9<sup>th</sup> December 2020, the United Nations Environment Programme (UNEP) launched its Emissions Gaps Report 2020, which is an annual update of global emissions pathways and progress towards achieving national mitigation pledges and the Paris Agreement goals as well as the resulting 'emissions gap'. On the 14<sup>th</sup> and 15<sup>th</sup> of December, EEG was invited to attend a webinar on the key findings as well as a Planet Unplugged event for the Report. With 51 expert authors and an illustrious Steering Committee guiding them, this

What is the emissions gap? The gap between estimated future global greenhouse gas (GHG) emissions if countries implement their climate mitigation pledges and the global emission levels from least-cost pathways that are aligned with achieving the temperature goals of the Paris Agreement. Thus, this difference between "where we are likely to be and where we need to be" is known as the 'emissions gap'. A panel consisting of the authors provided a short summary of their respective chapters, highlighting the following key findings:

Report was the 11th of its series in the UNEP repertoire.

- Greenhouse Gas (GHG) emissions continued to rise in 2019 for a third year in a row
- Fossil carbon dioxide (CO<sub>2</sub>) emissions dominated the total GHG emissions
- 3. It was estimated that  $_{\rm co2}$  emissions could decrease by about 7 % in 2020 due to the COVID-19 pandemic. However, atmospheric concentrations of GHGs continue to rise.
- Despite a short-term reduction in global emissions due to the pandemic, there would be no significant contribution to emissions reduction goals by 2030. This will only be possible if countries incorporate decarbonisation as part of their economic recovery.

- According to UNEP, the rising number of nations committing to netzero emissions goals by around mid-century is highly encouraging. However, these need to be urgently translated into strong policies and action
- 6. It is estimated that the G20 members will overachieve their modest 2020 Cancun Pledges, but are not on the right track to achieve their respective NDC commitments. The breakdown is as following: Countries on track to achieve their 2030 NDC commitments: 9; Countries not on track to achieve their NDC commitments: 5; Countries that have insufficient information to determine status: 2.
- 7. Current NDCs remain seriously inadequate to achieve the climate goals of the Paris Agreement and would lead to a temperature increase of at least 3°C by the end of the century.
- 8. The COVID-19 recovery packages by governments are unprecedented: roughly US\$12 trillion globally, or 12 % of global gross domestic product (GDP) in 2020.
- Domestic and international shipping and aviation currently account for around 5 % of global CO<sub>2</sub> emissions and are projected to increase significantly. International emissions from shipping and aviation are not covered under the NDCs and, based on current trends, are projected to consume between 60 and 220 % of allowable CO<sub>2</sub> emissions by 2050.
- 10. Lifestyle changes are a prerequisite for sustaining reductions in GHG emissions and for bridging the emissions gap. Around two thirds of global emissions are linked to the private household activities according to consumption-based accounting.

EEG would like to congratulate UNEP and the authors on this extraordinary report. We hope countries across the globe remain committed and determined to meet their NDCs, while on the road to recovery.



# **16**th Advancing Equitable Livelihoods in Food Systems

December EEG Chairperson was invited to attend a virtual dialogue on food systems and food security on 16th December. This was part of the UN DESA Global Policy Dialogue Series and a UN Food Systems Summit Dialogue.

Poverty and food security continue to be major challenges for humanity and in this regard, to support the United Nation's efforts to eradicate hunger and make food available to everyone, UN DESA held this virtual session in the context of rural development and demographic change. The event was attended by internationally reputed thought leaders in the field of food systems, population trends and rural development.

The meet was dynamic and highlighted three key areas of discussions; the impact of covid-19 on food systems and availability to people especially in developing countries; examples of agricultural and non-agricultural technologies that can be used in rural areas for sustainable productivity and implications of people movement on food systems.

- 1) to review the progress made by GUD during 2020, especially on two major initiatives (Sustainable Innovation Zones and Sustainable Innovation Communities; and Dubai International Housing Symposium, 3D printed affordable housing with recycled construction waste, and Dubai Expo 2020) 2) to re-elect the Board
- 3) to engage in strategic planning for 2021.

# th "For Our Emirates We Plant"

This year, "For our Emirates We Plant" project saw the participation of 92 companies, 36 schools and 240 families.

Upon the conclusion of this event, EEG has planted 2,100,789 indigenous trees across the different Emirates since 2007, which has helped in the sequestration of 12,388 Metric Tonnes of CO<sub>2</sub> emissions annually.

This waste management project is exclusively rolled out for student members. ## UAE to Raise Clean Energy Use to 50% by 2050

The UAE Government has taken sustainable development goal no 7 - Affordable and Clean Energy, very seriously and is leaving no stone unturned to make this happen through strict policies and awareness programmes to implement them. The Ministry of Climate Change and Environment (MOCCAE) officially launched the country's Environmental Policy on 16<sup>th</sup> December with the aim to raise the use of clean energy in UAE to 50% by 2050.

The policy was approved by the Cabinet in late November this year. It stands on eight main pillars: Climate change; environmental protection; air quality; food safety and security; sustainable local crop production; sustainable local livestock production; integrated waste management; and environmentally sound chemicals management.

"Each pillar identifies a host of initiatives aimed at achieving its goals," said H.E. Dr Abdullah Belhaif Al Nuaimi, Minister of Climate Change and Environment. The policies were developed in cooperation with strategic partners after a thorough review of the environmental situation in the country.

# Climate Emergency Declared by UN Secretary General

"Can anybody still deny that we are facing a dramatic emergency?", said the UN Secretary General who also declared an authoritative warning about the future of the planet at the Climate Ambition Summit on 12<sup>th</sup> December. The world has completed five years of Paris Agreement on climate change with no significant progress.

The UN Secretary General on this occasion strongly called every country to declare climate emergency till it achieves carbon neutrality. We are indeed at the brim of another crisis and without any ignorance, every country needs to be firm on their climate actions for the sake of future generations. The Summit was co-convened by the UN, the UK COP Presidency and France, in partnership with Chile and Italy to bring leaders together to make new commitments towards the Paris Agreement.

Britain, co- hosting the summit, made one of the clearest new commitments, announcing it would stop direct government support for overseas fossil fuel projects. Additionally, many member states renewed their pledges for faster action. Argentina, Barbados, Canada, Colombia, Iceland and Peru were among 15 countries who shifted from "incremental" to "major" increases in their emissions pledges.

### The 59th GEF Council Meeting

"Land restoration benefits people and nature. A restoration economy will create millions of green jobs and enhance humanity's resilience to future shocks and stresses. Revitalising terrestrial ecosystems, such as farmlands, grasslands, forests and wetlands rebuilds their ability to store carbon and reduce greenhouse gas emissions.

Done well, it can also protect habitat for biodiversity, build soil fertility and reduce water scarcity", said the UNCCD Executive Secretary at the 59th Global Environment Facility (GEF) Council Meeting. He further highlighted that the G-20 leaders have launched the Global Initiative on Reducing Land Degradation and Enhancing Conservation of Terrestrial Habitats to prevent, halt, and reverse land degradation.

The G-20 initiative shows an unprecedented resolve by the world's largest economies to conserve the terrestrial environment, and is expected to focus on capacity building, engaging the private sector and civil society. A study of all the global initiatives to restore degrading land shows that close to one billion of the two billion hectares of land that is degraded can be restored.

"Building on existing initiatives, we share the ambition to achieve a 50% reduction of degraded land by 2040, on a voluntary basis" states the Leaders' Declaration issued in November 2020.
