Dear Members & Readers,

The UAE's efforts to achieve Net Zero by 2050 are in full swing! It is the first in the MENA region to take on this strategic initiative, in line with the Paris Agreement, to reduce GHGs naturally resulting in the halt of global temperature rise to 1.5 degrees Celsius. But how is UAE achieving these goals? And as citizens and residents of this country what is that we can do to accelerate the process?

It is very important to understand that to create a healthy and sustainable environment, one must first learn to keep the very components that make up the environment, in good condition. Just as we need to keep the different areas of our homes clean regularly and not neglect any part of our home, so do we need to do the same for the land that we reside on. Failing to do so results in turmoil and today we are faced with the 'Triple Planetary Crisis'.

CEBC on Building Blocks for Developing an ESCO Market in Lebanon

EEG attended on **5th September** a launch webinar of a white paper entitled “Building Blocks for Developing an ESCO Market in Lebanon” authored by the Clean Energy Business Council (CEBC) and the Issam Fares Institute for Public Policy and International Affairs (IFI) at the American University of Beirut (AUB). In the past years, the power supply in Lebanon has become highly erratic, with the publicly provided, Electricité du Liban, electricity increasingly being replaced by expensive private diesel-powered generators that are a major source of pollution blanketing urban areas, with severe negative health impacts. Lebanon has substantial, largely unexploited, renewable energy potential: hydro, wind, and solar.

Despite this potential, Lebanon has become extremely fossil fuel dependent with a highly inefficient power supply, power stations beyond their technical and economic life and a sector characterised by waste, corruption and inefficiency. Improving energy efficiency and changing the energy mix towards renewables are the first steps. Building an ESCO market should be an element in an inclusive energy policy within a more comprehensive economic policy and institutional reform framework. The paper aimed to set the basis for the development of an ESCO market in Lebanon in the coming years by identifying building blocks and analysing best practices and trends, both at the international level, and specifically in the MENA region, focusing on the UAE, Saudi Arabia, Morocco, and Oman. It also dived into the nascent ESCO market in Lebanon, through the dissection of the current legal and institutional frameworks, before proposing some concrete recommendations at the policy, technical, and financial levels.

ICGN Global Stewardship Awards 2022

Co-Founder and Chairperson of the Emirates Environmental Group, Mrs. Habiba Al Mar’ashi, took part in the prestigious and internationally recognised ICGN Global Stewardship Awards 2022 as one of their esteemed judges amongst a panel of five other dignitaries from around the globe. The Stewardship Disclosure Award is to honour Asset Managers that follow a full-fledged protocol in maintaining transparency of the impact and implementation of their policies with over US\$ 60 billion assets under management.

The criteria was simply to award the best disclosure model which could further be followed by others in the future. These awards measure the execution of stewardship by the investor and asset owners backed by clear documentation, as well as the policies highlighting their CSR and the practices used to implement them. The award recipients will be confirmed by the ICGN Awards Committee and the winners will be disclosed at the ICGN Awards Ceremony and Webinar on 1 December 2022.



14th - 15th September Green Building Week 12-16 September 2022

Co-Founder and Chairperson of EEG, Co-founder & Treasurer of The Emirates Green Building Council (EGBC) and Board member of the World Green Building Council (WGBC), Mrs. Habiba Al Marashi, was an active attendee at the MENA NET Zero Collaborators programme on **14th September** in line with the UAE's effort in achieving Net Zero carbon emissions by 2050. The programme highlighted the role of collaborators in the expedition of sustainable built, green infrastructures within MENA, upholding their efforts in decarbonising the environment. The strategic initiative calls on the shift to the use of clean and renewable energy sources in a mission to reduce GHGs.

Collaterally, Mrs. Habiba attended the #BuildingToCop27 Forum on the **14th** and chaired a panel discussion on **15th September** ‘Building for the Economy’ at the Dubai Chambers of Commerce. It stressed the threats the population is set to face by 1.6 billion urban dwellers exposed to high temperatures and at risk of coastal flooding. This can be negated with the integration of sustainable builds as 40% of the global carbon emissions are due to poor and unhealthy buildings. The idea centers around designing for resources in a way to keep the materials in, and the waste out. Creating an ongoing loop of what goes around comes around, but with renewable sources which will in turn heavily aid in reducing GHGs. Further, this will benefit companies in assessing their ESGs such as their financial responsibility towards their climate commitments, transparency of policies and employee well-being, to name a few. To conclude the matter, in order to collectively reach Net Zero Emissions by 2050 and align with the ambition and goals of the nation, the collaboration between different entities, sectors and industries to mitigate carbon emissions is a combined effort and the only way to move forward.

GISD Work Stream Meeting on SDG Reporting and Metrics

EEG Co-founder & Chairperson Ms. Habiba Al Mar’ashi, attended virtually the GISD Work-stream Meeting on **15th September**. The discussion revolved on the recognition of the two exposure drafts set by the International Sustainability Standards Board (ISSB).

It proposed the General Requirements for Disclosure of Sustainability-related Financial Information and Climate-related Disclosures. To allow investors to assess the risks and opportunities within these areas. Other key takeaways observed from the report was to offer quantitative metrics in line with qualitative ones with main public targets using these metrics.

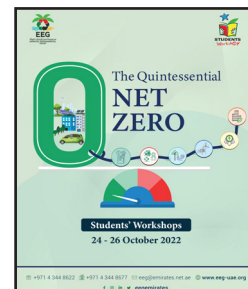

Remarks by Executive Secretary of the United Nations Convention to Combat Desertification

In a recent statement by Mr. Ibrahim Thiaw, Executive Secretary of the United Nations Convention to Combat Desertification, he mentioned that G20 joint environment and climate ministers' have made a multitude of commitments to restore planetary health. The focus of the UNCCD is: turning commitments into actions. This means achieving land-degradation neutrality - including restoring land and helping drought-prone countries to put in place drought-smart strategies. The UNCCD supports, for instance, the Great Green Wall initiative, which aims to restore 100 million hectares of degraded land, sequester 250 million tonnes of carbon and create 10 million green jobs in the Sahel by 2030. UNCCD has been working with the Kingdom of Saudi Arabia to operationalise the Global Initiative to support countries with their restoration efforts. Like-wise the Saudi-led Middle East Green Initiative, aims to back regional nature-based solutions and plant billions of trees. Most recently, the 2.5 billion dollar Abidjan Legacy Programme launched by President Ouattara at the 15th Conference of the Parties held in Abidjan under the leadership of Côte D'Ivoire, will help future-proof supply chains while tackling deforestation and climate change.

UNEP's Frontiers Report 2022

"Humanity has altered the planet in many detrimental ways, from the warming of our climate to the ever-diminishing wildernesses on land and in the sea. But in such a complex system as the Earth, science must always keep searching - for both solutions to problems already identified and new threats coming our way." - Inger Andersen, Executive Director - UNEP. The UN Environment Programme (UNEP) works to identify and draw attention to emerging issues of environmental concern. The UNEP Frontiers' report continues to advance this work, signaling environmental issues and solutions for effective and timely responses. Some issues may be local, relatively small-scale issues today, but may have the potential to become an issue of regional or global concern if not addressed early. UNEP's Frontiers Report does this by identifying and exploring areas of emerging or ongoing environmental concern. The 2022 edition delves into three issues: noise pollution in cities, the growing threat of wildfires and shifts in seasonal events - such as flowering, migration and hibernation, an area of study known as phenology. This report helps us understand that learning from ecosystems and how to live within them in harmony are objectives that we all need to adopt.

The Gender Snapshot 2022

In the month of September, UN Women and the UN Department of Economic and Social Affairs (UN DESA) launched a special report which highlights that, at the current pace of progress, SDG 5 - achieving gender equality - will not be met by 2030. At the current rate of progress, it may take close to 300 years to achieve full gender equality, the Progress on the Sustainable Development Goals (SDG): The Gender Snapshot 2022 shows. Global challenges, such as the COVID-19 pandemic and its aftermath, violent conflict, climate change, and the backlash against women's sexual and reproductive health and rights are further exacerbating gender disparities. The report estimates that it will take up to 286 years to close gaps in legal protection and remove discriminatory laws, 140 years for women to be represented equally in positions of power and leadership in the workplace, and at least 40 years to achieve equal representation in national parliaments. To eradicate child marriage by 2030, progress must be 17 times faster than progress of the last decade, with girls from the poorest rural households and in conflict-affected areas expected to suffer the most. The report also points to a worrisome reversal on the reduction of poverty, and rising prices are likely to exacerbate this trend.

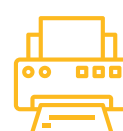

EEG has collected 260,351 kg of Paper from 227 participants during the month of September 2022, an increase of 77% compared to August 2022.
