Additionally, EEG engaged in a capacity-building workshop on stakeholder engagement and gained insights into UNEP's Resolution Portal at a dedicated information session. The month concluded with an acknowledgment of facilitators for informal consultations leading up to UNEA-6. On **January 8th**, I was honoured to be a speaker at the Qatar Media Symposium, addressing "The Role of Environmental Media in Sustainable Development." Here, I shared insights on environmental awareness and the importance of promoting sustainability far and wide.

As the Co-founder, 2nd Vice-Chair, and Treasurer of Emirates Green Building Council (EGBC), I played a pivotal role in two key events in January. I virtually attended the 1st MC Meeting on **January 10**, contributing to discussions on focus areas, budget, and strategies. Additionally, on **January 19**, I participated in a collaborative workshop within the EmiratesGBC Women's Network, engaging in discussions on expectations and sharing insights in a Fireside Chat to empower and shape the network's vision.

Recognising the importance of spreading the message of sustainable development across diverse platforms, I was invited to share insights on "The Road to Sustainability Podcast" by ARAMEX on **January 16**. Here, I discussed the challenges and successes of integrating green building principles into organisational frameworks.

Partnerships and collaboration play a pivotal role in advancing the sustainability mission as emphasised by UN SDG #17. Thus, I am pleased to announce that on **January 18th**, EEG joined forces with Panasonic in the 'For Our Emirates We Plant' initiative. This on-going partnership exemplifies our dedication to fostering positive climate action in the private sector. As the environmental partner of the Arabia CSR Network, EEG proudly participated in the launch of the 17th cycle of the 'Arabia CSR & Sustainability Awards' at Atlantis Palm Jumeirah on **January 22nd**. In my capacity as President & CEO of Arabia CSR Network, I unveiled the Awards' transformation, highlighting its 20-year journey and the addition of the Education Sector category. This expansion reflects the commitment to holistic sustainability practices in the Arab world.

Celebrating a community triumph on **January 24th**, EEG, in collaboration with Dubai Municipality, organised a large-scale tree-planting initiative under the banner "For Our Emirates We Plant." **1,308** saplings of native trees were planted. These trees are projected to absorb **7.71** MT of CO₂ emissions upon maturity in 3-5 years. Since the inception of the program in 2007, EEG has successfully planted **2,126,912** indigenous trees, contributing significantly to the reduction of approximately **12,541.76** MT of CO₂ emissions annually.

In a milestone event on **January 29**, EEG hosted its first panel discussion of the year, focusing on "Climate Fund Transparency: Outlining Implementation & Execution". At this event, I highlighted the critical role of transparency in climate finance for effective global sustainability. Collaborating with key partners, the panel delved into the concept, challenges, tools, and case studies available in transparently allocating funds for impactful climate action.

From **29th to 31st January**, EEG actively participated in the World Environmental Education Congress, showcasing our impactful education programs and engaging with global leaders. This event underscored our commitment to environmental education, empowering youth, and fostering sustainable development worldwide.

I also had the honour of attending the launch of the "Zero Government Bureaucracy" program by the Ministry of Cabinet Affairs, on **January 30th**, supporting streamlined government processes and enhanced efficiency. The initiative aims to eliminate redundant procedures and requirements, with a commitment to cancelling 2,000 government measures by 2024, fostering transparency in operations. These initiatives align with EEG's mission for a more progressive future.

In a momentous gathering on **January 30th**, I led the 30th EEG Board Meeting, celebrating our triumphs in 2023 and charting an ambitious course for 2024. Gratitude was extended to members, partners, and volunteers for their pivotal roles in EEG's success. I unveiled the 2024 budget, showcasing a commitment to expanding impact through innovative initiatives.

In addition to participating in events throughout the UAE, I proactively engaged with the media. This included a TV interview on Abu Dhabi TV's "Sabah Al Emarat" program on **2nd January 2024**, highlighting EEG's achievements in 2023. Post the Qatar Media Symposium event, on **25th January**; I was interviewed by Qatar Radio to provide my thoughts and opinions on the importance of media role and such events. Another significant interview took place on **29th January** with Al Khaleej, where I passionately discussed the importance of climate finance transparency after our panel discussion.

As we navigate the intricate web of challenges and opportunities that lie ahead, the Emirates Environmental Group remains steadfast in its mission to cultivate a culture of environmental responsibility. 2nd January A Glimpse into EEG's Achievements with Abu Dhabi TV Interview

In an engaging interview on Abu Dhabi TV's "Sabah Al Emarat" programme held on **2nd January 2024**, EEG Chairperson, highlighted the organisation's environmental achievements in 2023, most notably the successful Clean UAE campaign which engaged **68,017** members of the community. The insightful conversation showcased EEG's vision and the importance for a cleaner UAE. The interview featured a special highlight reel film of the event, shot by EEG's creative team, offering viewers a first-hand look at the initiatives towards a cleaner and greener nation. She eloquently shared the organisation's impact with the Clean UAE event which spanned the **7** Emirates and covered a total area of **36.5 km²** from **December 5th** to **16th**.

The campaign amassed a substantial collection of **36,900** kg of waste, showcasing a collective commitment to a pristine environment. This TV feature celebrated EEG's accomplishments and also served as a call to action, inviting individuals to join in creating a more environmentally conscious community.

8th January EEG's Insights at Qatar Symposium

8th January

In a symposium, held on **8th January**, on "The Role of Environmental Media in Sustainable Development" in Qatar, organised by the Qatar Media Corporation and under the patronage of H.E. Sheikh Abdul Aziz bin Thani Al Thani, EEG chairperson shared transformative insights on environmental awareness and the importance of media platforms. The event was held in cooperation with Gulf Radio and Television affiliated with the general secretariat of the Gulf Cooperation Council and the Expo 2023 committee in Doha. It attracted a diverse audience committed to sustainable development. 

EEG's Active Involvement with UNEP in January

January 11th - Key Highlights from UNEA's Draft Resolutions

EEG Team virtually attended a meeting of the Committee of Permanent Representatives Subcommittee held on **11th January** in Nairobi; crucial discussions took place on UNEA draft resolutions addressing global environmental challenges. The meeting covered diverse topics and policy improvements such as highly hazardous pesticides, sand & dust storms, water policies, land degradation, nature-based solutions, cascade systems, air quality and more.

Delegations raised insightful questions and suggestions, emphasising integration, budget implications and alignment with existing frameworks. The resolutions, presented by various nations, showcased a commitment to collaborative global efforts. The meeting concluded with an invitation for further consultations on the draft ministerial declaration, a reminder about the co-sponsorship process and upcoming speaker lists for national statements at UNEA-6.

January 17th - Navigating Stakeholder Engagement Dynamics in Pre-UNEA

EEG immersed itself in the intricacies of stakeholder engagement at a preparatory capacity building workshop hosted by the United Nations Environment Programme (UNEP) on **17th January**, the world's highest decision-making body on environmental matters. In collaboration with the Major Group and

Stakeholder Facilitating Committee (MGFC), the workshop aimed to enhance our understanding of the Major Group modality within UNEP, a key element in shaping global environmental policies. Discussions centred on effective coordination strategies for Major Groups in the lead-up to the United Nations Environment Assembly (UNEA-6). As fervent advocates for environmental sustainability, this event provided an opportunity to increase our understanding of stakeholder engagement possibilities in UNEP and to develop a joint approach to Major Group coordination towards UNEA-6. EEG's active participation in global forums reinforces our commitment to contributing insights and experiences to the international dialogue on pressing environmental concerns.

January 18th & 23rd - CPR Subcommittee Meeting for UNEA-6 Drafts

EEG Team virtually attended two meetings for the Committee of Permanent Representatives Subcommittee Meeting on **18th & 23rd January**, where the UNEA-6 draft resolutions witnessed substantive discussions. A variety of draft resolutions were presented, reflecting the global commitment to addressing critical environmental issues. Highlights included Switzerland's proposal on the sound management of chemicals and waste, with queries focusing on UNEA-6's role and operational details. Concerns and suggestions arose regarding the draft resolution on solar radiation modification, emphasising the need for scientific assessments and social expertise. Costa Rica's initiative on strengthening ocean governance



prompted questions about terminology and UNEP's strategic role. Other topics covered included environmental assistance in conflict areas, minerals and metals, circular economy, sustainable lifestyles and more. The meeting concluded with discussions on procedural matters, including the provisional agenda, date, and venue for the seventh session, trust fund management, and preparations for the high-level segment.

January 25th - 164th & 165th Meet of the CPR to the UNEP

Emirates Environmental Group virtually attended the 164th & 165th meeting of the Committee of Permanent Representatives (CPR) conducted on **25th January** in Nairobi, Kenya. CPR prepares the meetings of the UN Environment Assembly of UNEP and regularly reviews the implementation of its decisions.

The agenda included the adoption of the provisional agenda and draft minutes, as well as the consideration of the Chair's Summary of the 10th Annual Subcommittee meeting. The Executive Director presented a Quarterly Report, covering **July to September 2023**, and discussions focused on relevant evaluation reports and audits. Additionally, preparations for the upcoming United Nations Environment Assembly session and a report from the subcommittee were addressed.

January 25th - UNEA-6: Facilitators Announced for Crucial Draft Resolutions and Decisions

The UN Environment Assembly (UNEA) and the Committee of Permanent Representatives have jointly revealed the appointment of 7 facilitators for informal

consultations on draft resolutions and decisions leading up to UNEA-6 on **26th February**. H.E. Leina Benali, President of UNEA, and H.E. Firas Khouri, Chair of the Committee of Permanent Representatives, announced the facilitators in a collaborative letter. The appointed facilitators, including delegates from Canada, Chile, India, Japan, Kenya, Sweden, and the United Republic of Tanzania, will play an important role in steering the consultation and negotiation processes.

The remaining 3 facilitators will be disclosed in due course. The joint effort emphasises transparency and inclusivity in the preparatory stages for UNEA-6, fostering cooperation among member states and stakeholders.

January 26th - UNEP's Resolution Portal Information Session for Environmental Policies

EEG participated in the UNEP event held on **26th January**, focusing on UNEP's Resolution Portal, which provided valuable insights into enhancing our role in shaping environmental policies. With a dedicated session led by the UNEP team, EEG gained a deeper understanding of the portal's functionalities.

As advocates for sustainable practices, EEG is poised to actively engage with UNEA-6 preparations. Our presence at the event aligns with our mission to contribute meaningfully to environmental discussions and collaborate with diverse stakeholders. We look forward to leveraging this knowledge to drive positive change and promote sustainable development.

Saudi Arabia to host largest-ever UN COP16 conference on land and drought

The Kingdom of Saudi Arabia and the United Nations Convention to Combat Desertification (UNCCD) have inked an agreement to organise the 16th session of the Convention's Conference of the Parties (COP16) in Riyadh from **2-13 December 2024**. Representing the largest-ever UNCCD meeting with UNCCD's 197 parties, the Riyadh COP16 aims to address global land degradation, drought emergencies, and sustainable land management. As the 1st biodiversity COP in the Middle East, hosted by Saudi Arabia as their largest multilateral conference, the event coincides with the UNCCD's 30th anniversary. With 40% of the world's land degraded and droughts intensifying, the conference seeks global collaboration to restore 1.5 billion hectares of land by 2030. The Riyadh COP16 will focus on mobilising governments, businesses, Civil Society organisations and communities worldwide to accelerate action on land restoration and drought resilience as a cornerstone of food, water and energy security.
